






# MAY BCP CONT.

#### <u>COLA</u>:

- Civil Code section 1798.199.95 provides for an adjustment to the General Fund appropriation to reflect cost-of-living changes to support Agency operations each fiscal year.
- Per the Board's direction, we requested to increase the Agency's budget by a cumulative COLA for fiscal years 2021-22, 2022-23, and 2023-24, and a one-time true-up for previously unrequested years.
- We received \$1,215,000 for the cumulative COLA and \$602,000 for one-time "True-up."



# FY 2024-25 (PROSPECTIVE) BUDGET REQUEST

#### **Future BCP Considerations:**

- Requesting resources for moving contracting in-house as Agency grows
  - CPPA currently utilizes DGS Office of Business and Aquisition Services (OBAS) procurement services for contracting.
  - OBAS plans to phase out providing procurement services for client agencies over the long term.
  - In preparation, and to improve processing time for contracts, we are considering seeking Tier 1 purchase authority in-house.
  - CPPA expects 3PY to take on Tier 1 contracting.
- Resources for increased litigation costs (TBD)
- In line with 2023-24 Budget, CPPA will request COLA adjustment
- In addition, CPPA will request 'memorialization' for automatic COLA adjustment via Trailer Bill Language for future years

(Timeline: Fall BCP due, January Budget Published, Spring/May Revise, July 2024 enacted)
