MA, S. 2608	Passed the Senate; Referred to the House
MI, SB 359	Awaiting Senate vote
PA, HB 77	Passed the House; Referred to Senate
WI, AB 172	In Assembly Committee

# CA 2025 Session Wrap - CalPrivacy Position Bills

Bills	Update
AB 566 (Lowenthal) CA Opt Me Out Act SPONSORED	Signed into law, effective date 1/1/27
SB 361 (Becker) Data Brokers SUPPORT	Signed into law, effective date 1/1/26
SB 470 (Laird) Bagley-Keene: Teleconferencing SUPPORT	Signed into law, effective date 1/1/26
AB 302 (Bauer-Kahan) Data brokers: elected officials & judges SUPPORT IF AMENDED	Designated a two-year bill
AB 322 (Ward) Precise geolocation information SUPPORT	Designated a two-year bill

AB 1018 (Bauer-Kahan) Automated Decision Systems WATCH	Placed on inactive file
AB 1043 (Wicks) Age Verification Signals WATCH	Signed into law, effective date 1/1/27
AB 1064 (Bauer-Kahan) LEAD for Kids WATCH	Vetoed
SB 7 (McNerney) Employment: Automated Decision Systems WATCH	Vetoed

# California 2025 Session Wrap – Legislative Engagement

- Legislative staff briefing
- Senate outreach 88%
  - Meetings with Senator or staff 52%
- Assembly outreach 75%
  - Meetings with Assemblymember or staff 40%
- 53+ total in-person meetings

## California 2026 Session – Bill Positions

## **Sponsorship**

- Working with legislator to draft bill
- Engaging with stakeholders
- Communicating agency position to legislators

### **Support**

- Providing technical assistance to the bill's author
- Communicating agency position to legislators

## California 2026 Session – CCPA Bill Proposals

#### **Establish Comprehensive Whistleblower Protections**

- Award program to incentivize whistleblowers
- Special designation program that enables the Enforcement Division to collaborate with whistleblower attorneys on certain cases & allows whistleblower to share a portion of an administrative award
- Anti-retaliation provisions to protect whistleblowers

Extend the Right to Delete to All Personal Information Collected About a Consumer

Require Alternative Methods for Submitting Consumer Privacy Requests
